To maintain consistency and compliance, we do not allow the sale of baked goods as fundraisers - both to meet Florida food safety regulations and to respect our vendors' offerings. Please include proof of nonprofit status with your application.

For the comfort and enjoyment of our guests, active solicitation is not permitted. Visitors must approach your booth voluntarily; representatives may not approach customers as they browse the market. The market does not allow political organizations.

In recognition of the sensitive and often volatile nature of today's political climate, and to maintain a positive, family-friendly atmosphere for all attendees, the market does not permit participation from political parties, campaign organizations, or groups promoting partisan causes.
